

Ahmednagar, Maharashtrata establish the memorandum of understanding (MoU) and collaboration programme/research on related matters of mutual interest and benefit that may emerge overtime.

#### OBJECTIVES OF THE PROGRAMME

- 1. The purpose of this MoU is to promote the collaborative research and to accelerate the high quality research acumen. The major drive of collaborative research will include the transfer of technology of mutual interest including and not limiting to material science. The mode of co-operation will include:
  - (a) Faculty and research student exchange for the purpose of research and teaching.
  - (b) Allow students to use the research laboratories and facilities.
  - (c) The development and implementation of new cooperative research projects, professional development programme, and capacity building efforts etc.
  - (d) The dissemination of findings through scholarly publication, white papers, and in the media.
  - (e) Mutual use of Books and Journals.
  - 2. To achieve the goal of this MoU, both parties will, in so far as the means of each allow:
    - (a) Facilitates the institutional exchange by inviting faculty and research student of the partner institute to participate in appropriate research activities.
    - (b) Participation and organised of symposia, workshops and conferences etc.

- (c) Develop and carry out joint research project.
- (d) Exchange information and results output pertaining to the research areas agreed upon.
- (e) To exchange faculty members, scholars and students amongthe colleges.
- 3. The initiation of any particular research activities will be proceed by prior discussion and agreed upon in writing by appropriate responsible representatives of both institutions.
- 4. The financial arrangement of any exchangeable research activities must be mutually understandable by both institutions and agreed upon will be depend upon the availability of funds.
- 5. Both parties may propose to the other individual research project for collaboration. Such proposal may be made at any time and parties will make arrangements for each agreed upon projects. The outputs of such activities will be addressed in each individual project agreement early and on-goingly.
- 6. Day to day implementation of this agreement will be coordinated by Dr. K. D. Rodage of the Department of Economics, Dada Patil Mahavidyalaya Karjat, Dist. Ahmednagar, Maharashtraand Mr. N. M. 





- All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing.
- Each of the participating institution shall be fully responsible financially for the activities carried out under its direction or by its staff, except as otherwise agreed by the parties.
- The parties will designate one officer each who will develop and coordinate specific programs or activities between them.

# DURATION AND RENEWAL OF AGREEMENT

This Memorandum of Understanding will become effective immediately after signature by the Principal and Head, Department of English, Dada Patil Mahavidyalaya, Karjat Dist. Ahmednagar and Yashwantrao Chavan Mahavidyalaya Karmala, Dist. Solapur for a period of 5 Years commencing from 21/02/2022 to 21/02/2027 and is subject to revision and modification through mutual agreement.
